Primary Shoreline Type/ Geology:

Bourne Cove is located to the northwest, Little Harbor Inlet to the east, and Buzzards Bay to the south.

 Bedrock underlying this segment is identified as undivided granite, gneiss, and schist (Zen, 1983).

05/16/2003	Oiled debris, rocks coated in oil, and puddles of free oil were observed near the southwest						
	portion of Warren Point. Oil splatter was also observed on cobbles and boulders along the jetty.						
	Surface oil coating observed primarily in the upper intertidal zone with up to 11% to 50%						
surface oil coverage in the gravel area in the upper intertidal zone.							
05/27/2003	Some oiled debris, tarballs, wrack patties, and splatter (up to 1 inch in diameter) were observed						
	on boulders and on the sandy portion of the segment primarily in the upper intertidal zone.						
	Residual oil was also observed in the marsh area. Additional cleanup activities were warranted.








NHESP 2005 MA PRIORITY HABITATS FOR STATE-PROTECTED RARE SPECIES


