#### PHYSICAL CHARACTERISTICS:

Primary Shoreline Type/ Geology:

• 1D: Rip rap seawalls, bulkheads, piers, docks, and pilings.

- 1B: Less utilized semi-public and private sand beaches;
- 1C: Mixed sand and gravel, gravel (pebble to boulder), and rip rap groins (jetties); and






