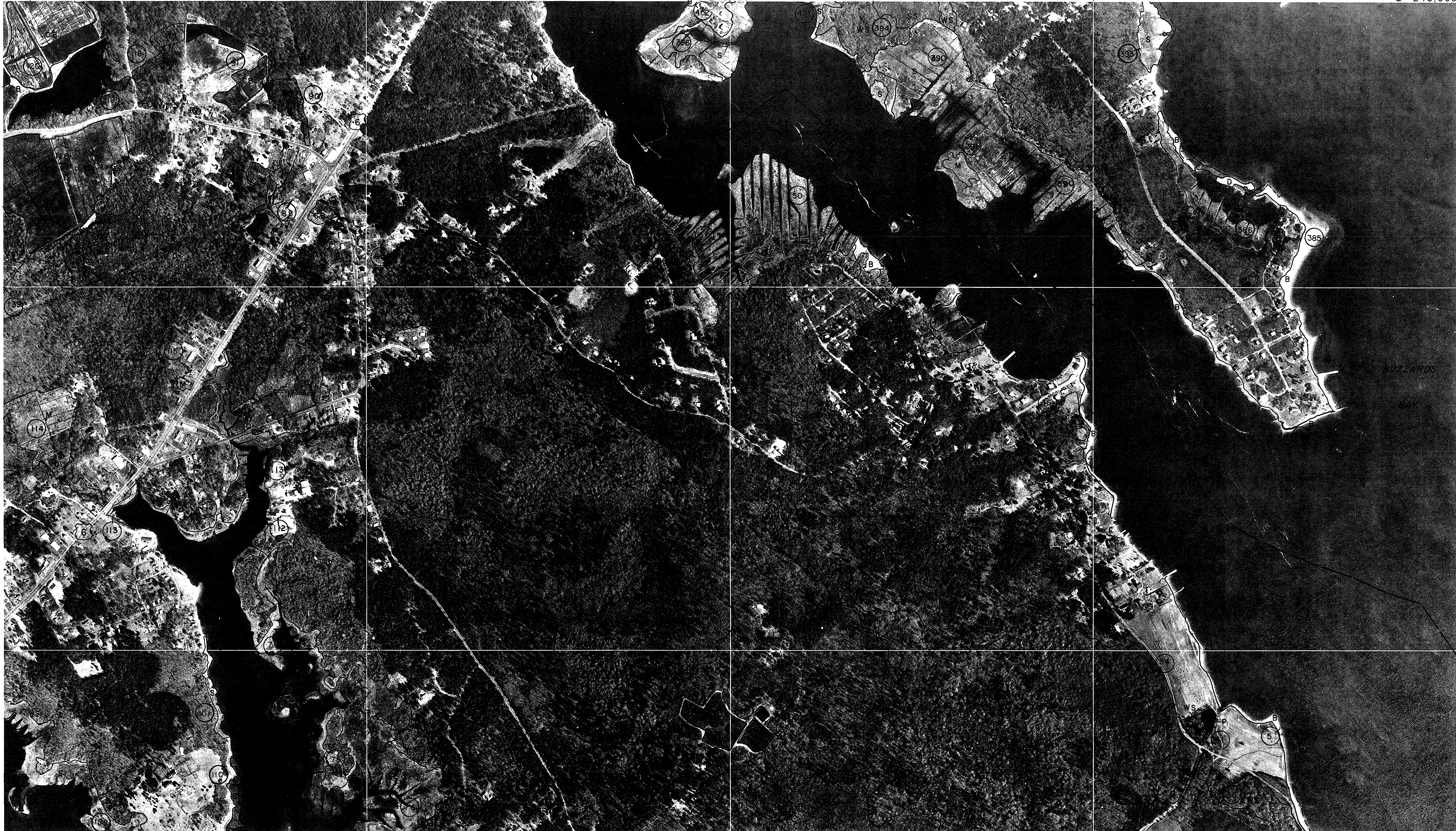
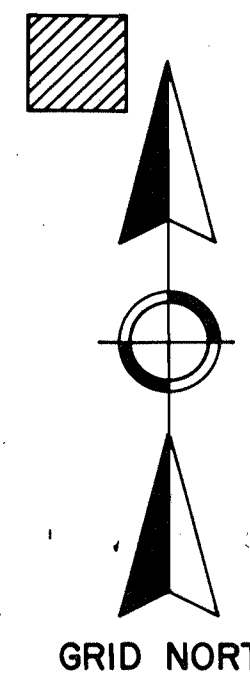

(MIN. UNIT MAPPED = 1/2 ACRE)



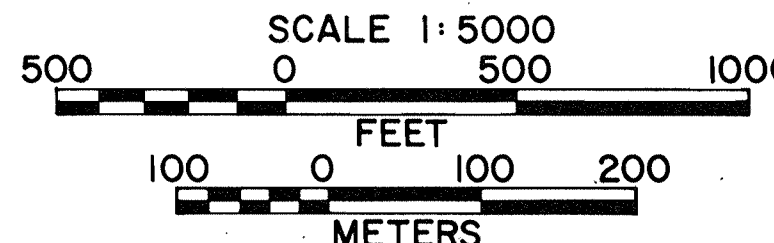
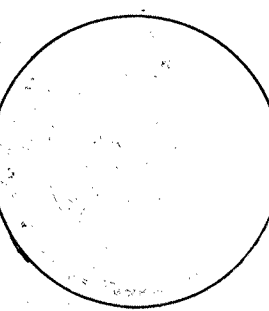
